

2014 ANNUAL STATISTICS

SUMMARY OF 2014 STATISTICS

OFFENSE TYPES/INCIDENT REPORTS

Law enforcement activities in Locust for 2014 proved to be another banner year for the city in terms of low criminal activity, and continued to show that city residents and visitors enjoy a safe environment, peaceful atmosphere, and "a wonderful place to live, work, and play!" Statistics documented by the Locust Police Department for the 2014 calendar year, although showing a slight increase in overall offense types and documented incident reports, showed another decrease in property crime related calls as well as essentially a non-existent rate of violent crime.

For the year, the Locust Police Department continued with its policies of reports being documented for dispatched calls where interaction with the public occurred. With that policy, the department showed just a slight 2.4% increase in incident reports documented compared to 2013, and offense types contained in these reports also increased by just 3.95%.

General service call types were down 3.6% from the previous year, and these non-criminal call types continue to represent the largest percentage of dispatched calls we receive. General investigation call types were up 15.6% however these types of calls also are usually non-criminal in nature. In general investigations, reports involving missing persons were at nine for the year. It should be noted that no missing person reports involved foul play or legitimate run-away activity, and all reported missing were located.

Most positively for the criminal activity we deal with most often in Locust, call types related to property crime and fraud were down again in 2014. Overall, property and financial crime call

types were down 3.5% from last year. Within this category, reports related to larcenies from businesses went up by just three reports from a year ago, larcenies from residences were down three reports, and activity related to larcenies from vehicles also dropped by six. Reports related to fraud activity also dropped by two compared to 2013. Overall larceny activity for the year showed another decrease from last year with an average daily occurrence in the city of 0.46, a decrease of 3.4% from 2013. Personal larceny activity reports related to persons, vehicles or residences, and not including businesses showed another sizeable decrease and was down 15.8% from 2013. This represents an average daily occurrence of just 0.13 in Locust.

General law enforcement/criminal activity call types were even from last year as 212 total offenses in this category were reported for the second straight year. Within this category, traffic offense related reports increased 9% and property damage offense reports were up 7.8%.

The largest increase for 2014 in offense types occurred in the category related to alcohol and drug offense types. These offense types can mostly be attributed to traffic enforcement and is partially reflected in the increase in citation charges for the year. Offense types related to alcohol and drugs increased from 46 to 87 for the year and points to an increase in DWI and drug enforcement by the department.

In the category related to assault offense types, an increase of nine was recorded compared to a year ago, from 17 to 26. Although this represented a 52.9% increase from 2013, the daily average occurrence remained very low with an average of just 0.07.

Serious crime reports were down to numbers near zero again in 2014. For the year, there were no offenses related to robbery or violent theft activity, and only two offense types related to sexual offenses.

BUSINESS/NEIGHBORHOOD PATROLS

For the majority of the 2014 calendar year, fuel prices continued to stay elevated enough for the department to continue its philosophy of efficient patrol of Locust neighborhoods and businesses. This philosophy results in adequate presence being shown in the city but with efforts being made to limit fuel expenditures and excessive mileage with patrol vehicles. This continued strategy again resulted in a decrease of documented patrols of Locust neighborhoods and businesses compared to 2013 however, 20,216 neighborhood and business patrols were still completed for the 2014 calendar year. Within the perspective of daily patrols; this represented just a decrease of 1.8 patrols conducted on average daily by the department this year as opposed to last. The result of the continued efficient patrol strategy resulted in another small decrease in daily patrols, yet contributed greatly to the department's fuel cost average DECREASE of 12.1% for full-time department patrol vehicles (Based on 2013/2014 budget year vehicle expenditure report).

ARREST CHARGES

Arrest charges in 2014 were 162, up from 128 in 2013. This 26.6% increase can also be attributed heavily to increased traffic enforcement by the department related to alcohol and drug activity. Although some charges may have been the result of outstanding arrest warrants, the

department made 35 arrest charges related to driving while impaired offenses and 23 arrest charges related to different types of drug activity.

CITATION CHARGES

Traffic safety and enforcement remained a priority for the Locust Police Department in 2014, with the primary goal of keeping Locust residents and all motorists safe, as well as an increase in DWI and drug enforcement. Citation charges were up 17.4% for the year; from 1203 in 2013 to 1412 in 2014.

For detractors that hold a perception of excessive traffic enforcement in Locust, despite the 17.4% increase for the year, the 1412 total citation charges represented a daily charge issuance average of just 3.9. In addition, traffic stops recorded by Stanly Communications mobile software showed that 1449 traffic stops conducted in Locust resulted in verbal or written warnings issued, 37 more than the total number of citation charges issued for 2014.

TRAFFIC CRASHES

A new statistic tracked for 2014 was traffic crashes recorded through Stanly Communications mobile software. Total recorded/reported crashes for the year (street/highway and pva/parking lots) in Locust was 134 for a monthly average of 11.2, and a daily average occurrence of just 0.37. No deaths in 2014 occurred as a result of a traffic crash in Locust.

LOCUST POLICE DEPARTMENT 2014 YEAR IN REVIEW

JANUARY

The January 2014 edition was issued simultaneously with the 2013 Year In Review edition of the newsletter.

A crime brief from December reported that Locust officers were able to locate and stop suspects involved in an early morning home invasion occurring in the county section of Coley Store Road.

We also reported the departure of Officer Ernie Wimbish, but only as a full-time officer. Ernie moved to reserve officer status so he could focus more on his gym, Pro-Fit. Officer Trent Middlebrooks had been hired as full-time patrol officer.

Update - Ernie's gym Pro-Fit continues to thrive offering numerous classes for all ages and fitness levels as well as sports specific training, cross-fit, and power lifting. FEBRUARY

The February edition of the newsletter reported on a pursuit of a stolen vehicle started by the Cabarrus County Sheriff's Office in Concord and ended with the driver running from the vehicle into a wooded area near the Locust city limits on Highway 200. Locust officers responded to assist with the search along with the Stanfield Police Department and Stanly County Sheriff's Office. After more than an hour of searching for the suspect, Locust officers located the man inside an abandoned trailer in the area. He was arrested without incident and custody transferred to Cabarrus deputies.

Also the newsletter reported another example of why neighborhood watch programs and the department's e-mail advisory list can be so beneficial and effective. A neighborhood watch and e-mail advisory list member in Meadowcreek Village made several reports of a suspicious vehicle in the area, reporting that the vehicle had arrived at around the same time frame on multiple occasions. This tip provided a time period for Locust officers to patrol the area and the suspect vehicle

was located. The driver, a Concord man was found to be in possession of drugs and drug paraphernalia. He was cited for the offenses and told not to return to the subdivision.

Update - The suspect apprehended by Locust officers in the Cabarrus vehicle pursuit was given over a year in the North Carolina Department of Corrections. The suspect caught thanks to tips on our e-mail advisory list received a probation type agreement for first time offenders.

MARCH

The March newsletter reported a recent Weekly Post article covering the recent winter storm and how the department's e-mail list kept members advised on weather and road conditions in Locust. I was privileged to participate and point out the positives of being an advisory list member. I also reported that I had been allowed to begin contributing articles to the Post to keep area citizens apprised of department activities and other crime prevention tips.

The newsletter also reported several scam and scam attempts in the Locust area as well as occurring nationwide.

APRIL

The April newsletter reported that the Locust Police Department had assisted the Lincolnton Police Department in the arrest of an individual who had sucked on a woman's toes at a Wal-Mart in Lincolnton. The offense transpired after he had convinced the woman he was a podiatry student and told her he could assist her with finding comfortable shoes. The offender, Michael Anthony Brown was identified by Locust officers due to him being arrested at the Locust Wal-Mart in 2012 for a similar offense. In the Locust incident Mr. Brown had used a similar ploy on a female customer before grabbing her foot and taking a photograph of it. Mr. Brown was arrested and later convicted of assault on a female.

Locust officers contacted Lincolnton and Mr. Brown was arrested for the Lincolnton offense. Brown was previously a registered sex offender for a similar offense that was more extreme in nature. This bizarre and troubling story made news across the country.

The April edition also reported that yours truly had received my intermediate law enforcement certification.



Update - Mr. Brown pleaded guilty and received a 60 day jail sentence for what would also be considered assault on a female. No update was available as of press time about Brown's current status.

MAY

The May newsletter contained numerous crime briefs from the previous month that included multiple DWI and drug arrests. These examples were reflected in the 18 arrest and 191 citation charges reported from the previous month. Eight of the arrest charges alone were for driving while impaired offenses.

JUNE

The June newsletter re-capped a huge previous month of May for the department in both extra-curricular and departmental activities.

A vehicle pursuit that started in the Midland area with the Cabarrus County Sheriff's Office pursuing a vehicle that had committed a minor traffic infraction ended up involving the Locust Police Department in a big way. The pursuit traveled through secondary roads throughout parts of Cabarrus, Stanly, and Union counties before heading toward Locust on Highway 200 South. At the intersection of Big Lick Road and Highway 200 South, Locust officer Dwayne Dietz deployed a "Stop Sticks" device when the vehicle approached; flattening both of the vehicles left tires. The vehicle came to a stop just outside of the Locust city limits and the driver was arrested after a very brief foot pursuit. Investigation after arrest revealed the driver to be impaired, the vehicle stolen, and also revealed that the driver had set fire to his own residence in the Charlotte area.

A second vehicle pursuit less than a week later occurred when Locust officers identified a stolen vehicle at the Locust Wal-Mart. When an attempt was made to stop the vehicle, the driver of the stolen vehicle led Locust officers and Cabarrus County deputies on a high speed pursuit on Highway 24-27 into Charlotte reaching speeds as high as 110 mph. The driver of the stolen vehicle lost control of the vehicle when he attempted to make a right turn on Harrisburg Road in Charlotte at an excessive speed. After crashing the stolen vehicle into a curb, the driver fled on foot but was captured by Locust officers and Cabarrus deputies a few hundred yards away.

The previous month was also a special month away from work activities for Locust officers T.J. Smith and Jeff Shew. Both Smith and Shew had finished their associate degrees in Criminal Justice at Stanly Community College. At the commencement ceremony, Smith also received the Annie Ruth Kelly Leadership Award for his role in creating an annual charity softball tournament and Shew

received the Edwin J. Snyder Jr. Exceptional Scholar Award. Shew gave the graduating class commencement address at the college's 6 pm ceremony.

Also, later in the month at the annual Thin Blue Line Awards dinner hosted by the Officer Jeff Shelton Foundation, Smith received one award and Shew received two. Both Smith and Shew received the Community Service award for their creation of the annual public safety softball tournament for area charities, and Shew also received the "Got Your Six" award for assisting his partner Smith in apprehending a combative suspect.





Update - The suspect in the pursuit that began in Midland was convicted on multiple charges and received more than five years in the NC Department of Corrections (DOC). Officer Dietz was also honored by the makers of the "Stop Sticks" device when he was nominated for the "Stop Sticks" Stick of the Month for May.

The suspect in the pursuit that began at Wal-Mart was also convicted of multiple charges including habitual felon. He received more than seven years in the DOC system and is still incarcerated in Mecklenburg County awaiting trial on numerous other charges.

JULY

The July newsletter re-capped a busy month of June for the department in traffic enforcement that resulted in drug arrests. A vehicle stopped for running a red light resulted in the arrest of a 16 year old for the possession with intent to sell and deliver marijuana as well as multiple weapons charges. Another vehicle stopped for speeding resulted in the arrest of two men for similar charges. Overall, the

previous month's statistics showed 17 arrest charges with 9 being drug or weapons related and 143 citation charges had been issued.

AUGUST

The August newsletter reported a traffic stop from the previous month that resulted in the discovery of a mobile "meth lab" by Locust officers. The stop, made for an expired registration plate revealed a system used to produce the highly dangerous and volatile drug crystal methamphetamine. The mobile meth lab is very popular with makers of the drug as it allows the maker to constantly move the apparatus to avoid detection. The volatility of the chemicals used to make the drug however, make this method incredibly dangerous. The driver was arrested and given a \$100,000 secured bond. He later received prison time for the offenses involved.


Also, Officer Kevin O'Connor achieved the highest regular honor a North Carolina law enforcement officer can complete when he received his Advanced Law Enforcement Certification from Chief Frank Hartsell at the July City Council meeting. O'Connor received the honor after six years in service, the minimum amount of time possible to serve and earn the certification. His achievement was aided by his previous completion of a Bachelor's degree in Criminal Justice. O'Connor became the fourth current Locust officer to earn their Advanced Certification.



SEPTEMBER

A very brief September edition of the newsletter detailed something I've already included in this year in review; Officer Dwayne Dietz's heroic and timely actions during a May vehicle pursuit that not only brought the pursuit to a peaceful and satisfying end, but also potentially prevented extensive property damage and/or injuries. Officer Dietz's use of a "Stop Sticks" device deflated the tires of a stolen vehicle that was being driven by a convicted felon who was impaired at the time.

That driver was traveling north on Highway 200 South at a high rate of speed toward the busy Main Street/Central Avenue intersection when Dwayne sprang into action. His nomination by the makers of "Stop Sticks" for their monthly award was very well-deserved. Dwayne's actions were indicative of a lot of things that happen in our field that ultimately prevent things from potentially happening. Very often these actions occur with the general public never even being aware of what risks could have presented themselves had an officer not taken a certain action. Dwayne's coolness under pressure was also remarkable in the situation considering at the time he had not been in law enforcement for even two years yet. Again, awesome work Officer Dwayne Dietz!



OCTOBER

The October newsletter reported about the Second Annual Stanly County Public Safety/Teacher's Charity Softball Tournament that had taken place in September. The annual event, created by Locust Officer T.J. Smith and assisted by Officer Jeff Shew was once again a tremendous success. Defending champions "Stanly County Public Safety" successfully repeated as champions going undefeated in the event and compiling 75 runs scored in just four games. More importantly, over \$2300 was raised for West Stanly Christian Ministries' "Day of Giving" event and a truck bed full of food and supplies for the Stanly County area's needy. Pre-planning has already begun for the third annual classic in 2015.





NOVEMBER

The November newsletter reported a crime brief re-cap from October where a Matthews man who had removed his ankle monitoring device was hiding in the Western Hills sub-division. After an extensive search by Locust officers, the suspect was found and apprehended without incident.

The newsletter also reported statistics that included 18 arrest charges and 92 citation charges from the previous month.

DECEMBER

The final newsletter of 2014 covered two community service activities Locust officers were involved in during the month. Locust officers Kevin O'Connor, Brittany Tucker, Chad Whitley, and Sergeant Rick Crayton participated in the "Shop With A Cop" program in Albemarle and Officer TJ Smith contributed to West Stanly Christian Ministries' "Day of Giving". Smith is already planning for more activities to aid the Christian Ministries' annual event. Also, O'Connor and Tucker intend to initiate a "Shop With A Cop" event in Western Stanly County in the coming year.
