

Locust Officer Honored With Second Officer Of The Year Award

After previously being named as Stanly County Officer of the Year for 2015 by the Officer Jeff Shelton Foundation, Locust Officer Trent Middlebrook was also named 2015 Officer of the Year by the Rotary Club of Albemarle and West Stanly in a June 30th ceremony.

The Rotary Club of Albemarle and the Rotary Club of West Stanly have jointly recognized a law enforcement officer of the year and a firefighter of the year for Stanly County.

The law enforcement officer is Trent Middlebrook of Locust Police Department and the firefighter is Battalion Chief Tony Russell of Albemarle Fire Department. In a ceremony on June 30 these individuals were recognized and presented with plaques by Albemarle Rotary Club President Elsa Mata and West Stanly Rotary Club President-Elect Fran Albritton.

Middlebrook led Locust Police in 2015 in traffic stops, traffic citations issued, DWI arrests, drug arrests and drug seizures. He has served as the coordinator for Locust for the Governor's Highway Safety Program and helped revitalize the Stanly Chapter of the Fraternal Order of Police where he serves as secretary and state trustee.

He spearheaded Locust's participation in the NC Harm Reduction organization which supplies law enforcement agencies with naloxone to combat heroin overdoses.

He also participated in the annual Stanly County Public Safety/Teachers Charity Softball Tournament to benefit West Stanly Christian Ministries' food pantry and the Day of Giving Christmas campaign.

All law enforcement agencies and fire departments in Stanly County were invited to nominate individuals for this recognition.

In making these recognitions the Rotary clubs of Albemarle and West Stanly recognize the contributions that all law enforcement officers and firefighters make in the community.

Rotary is a worldwide fellowship of business and professional persons for the purpose of the ideal of service above self.

In addition to Officer Middlebrook's two officer of the year honors, Locust Officers Brittany Tucker and Kevin O'Connor were both honored by the Officer Jeff Shelton Foundation with the "Everyday Hero" award for their community service work with the "Shop With A Cop" program they initiated. Locust Officer Dwayne Dietz was also nominated for the Officer Jeff Shelton Foundation "Got Your Six" award. For the last two calendar years (2014 and 2015) Locust officers have received 12 awards either related to education or job performance.

Former Locust Officer Named Oakboro Chief Of Police

After serving as interim Chief for several months, the Oakboro Town Council named former Locust Patrol Officer Thomas Edwin (T.J.) Smith III as the Chief of Police for Oakboro at their October meeting.

Chief Smith has served since 2008 where he worked as a deputy for the Stanly County Sheriff's Office for one year. He then worked as a patrol officer for the Locust Police Department from 2009 until he was named interim Chief of Oakboro in the summer of 2016. While at Locust in 2014 Smith earned an associate's degree in criminal justice from Stanly Community College and was named by the college that year as the recipient of the Annie Ruth Kelley Leadership Award for his work organizing an annual charity softball tournament to benefit area charities. Also in 2014, Smith was awarded the "Everyday Hero" community service honor by the Officer Jeff Shelton Foundation for the same reason.

During his time in Locust, Chief Smith was also awarded the Intermediate Law Enforcement Certificate by the North Carolina Criminal Justice Education and Training Standards Commission and achieved the rank of PO 2. Both achievements are based on officer training and experience in the field. Chief Smith

was elected to the Oakboro City Council in November 2015 and was offered the job of interim Police Chief when long-time Chief of Police Joe Lowder announced his pending retirement. Smith did resign from his seat on the Council in August.

Chief Smith brings an approach to law enforcement that is heavily community and service based, a quality that the city of Oakboro found to be imperative in the direction they wanted to see the department head.

On a personal note, TJ was my patrol partner for three years in Locust. Of anyone I've worked directly with, he is the one I always felt the most comfortable with while working, responding to calls, or conducting traffic stops. TJ is great talking with both victims and suspects when responding to calls, and although thankfully it was never needed he is also an outstanding shooter averaging a shooting percentage in the high 90's. I can also say hands down that TJ is the best community service officer in the entire county and there is never a time he is not willing to help anyone in need.

TJ himself will admit from an overall experience level both in the field and from an administrative standpoint he would not necessarily be qualified for the position. However, if you do the job ethically and aren't afraid to ask questions instead of just assume things, the wealth of experience is not necessarily the most needed quality in a small city such as Oakboro. TJ does bring with him a plethora of experience and knowledge in serving his community which will likely prove to be that much more valuable for a city he cares a great deal about. For that reason alone, I have no doubts he will do an outstanding job bringing his community together and promoting an outstanding working relationship between the police department and the citizens of Oakboro. Congratulations Chief Smith (TJ)!

DRUG ARRESTS AFTER LOCUST POLICE DEPARTMENT/STANLY COUNTY SHERIFF'S OFFICE JOINT OPERATION

The Locust Police Department recently partnered with the Stanly County Sheriff's Office and Stanly County Drug Task Force in the arrest of two Locust residents on multiple drug distribution and possession charges after lengthy investigations of both subjects. Details as follows:

After a months long investigation, Investigators from the Stanly County Sheriff's Office, Locust Police Department, Stanly County Drug Task Force and North Carolina State Bureau of Investigation executed a search warrant at 120 Jenkins Street in Locust on October 5th. Search warrant was acquired after lengthy investigation of Devin Hunter Jenkins, 23, of the residence. During search of the residence, investigators found what appeared to be a "lab" used to manufacture and produce methamphetamine ("Crystal Meth"). SBI Special Agents specifically trained in safe removal of hazardous "meth labs" were called in and were able to safely remove the drug making materials. Arrest warrants were obtained for Jenkins on the following 13 charges:

Felony:

2 Counts Maintain A Vehicle/Dwelling/Place For The Manufacture Or Distribution Of Controlled Substances

- 2 Counts Possess With The Intent To Manufacture, Sell, Or Deliver Schedule IV Controlled Substances
- 2 Counts Deliver Schedule IV Controlled Substances
- 2 Counts Sell Schedule IV Controlled Substances
- 1 Count Trafficking In Methamphetamine
- 1 Count Possession Of Methamphetamine Pre-Cursors

Misdemeanor:

- 2 Counts Simple Possession Of Schedule IV Controlled Substances
- 1 Count Possession Of Drug Paraphernalia

Jenkins was arrest on October 7th and placed under a \$260,000 bond.

On Monday October 31st after almost a year long investigation, Investigators from the Stanly County Sheriff's Office and Locust Police Department arrested Dennis Ray Collins,21, at his residence located at 317 Old Hickory Road in Locust. Collins was arrested on the following 13 charges:

Felony:

- 3 Counts Maintain A Vehicle/Dwelling/Place For The Manufacture Or Distribution Of Controlled Substances
- 2 Counts Deliver Schedule II Controlled Substances
- 2 Counts Sell Schedule II Controlled Substances
- 1 Count Possess With The Intent To Manufacture, Sell, Or Deliver Methamphetamine
- 1 Count Possess With The Intent To Manufacture, Sell, Or Deliver Schedule II Controlled Substances
- 1 Count Possess With The Intent To Manufacture, Sell, Or Deliver Schedule IV Controlled Substances
- 1 Count Deliver Schedule IV Controlled Substances
- 1 Count Sell Schedule IV Controlled Substances

Misdemeanor:

1 Count Possession Of Drug Paraphernalia

Collins was confined at the Stanly County Jail under a \$50,000 bond.

The Locust Police Department would like to remind all of our citizens that although we enjoy a very safe city with a very low incidence of serious crime, the potential for criminal activity is always present. We encourage all of our citizens to report any suspicious activity to our office as both of these investigations were partially initiated due to citizen complaints. We would also like to remind you that if you do believe criminal and particularly drug activity is occurring in your area, if you do not report it there is a good possibility that we will not be aware of it if no other "warning flags" appear. Finally, if you do report this type of activity, please be patient. Due to constitutional safeguards that we value, respect, and honor, investigations of drug activity take a long period of time to assure they are conducted ethically, legally, and in respect to the privacy guaranteed through the United States Constitution. If you have any questions, please don't hesitate to ask. Everyone take care and be safe.

FOUR ARRESTED IN LOCUST HOME INVASION

In the early morning hours of July 14th, the Locust Police Department responded to the report of a burglary and armed robbery "home invasion" at a residence located on Family Lane off of North Central Avenue. The resident of the address and a visitor were held at gunpoint after entry was made through the front door by two male suspects. The victim suffered a minor injury after being struck in the face by one of the suspects and reported prescription medication, currency, a firearm, and other items of value being stolen.

After initial investigation involving search warrants for phone records, the visitor at the residence at the time of the robbery was determined to be involved. On July 25th, Ms. Donna Christine Hammill of Concord was arrested on charges related to the burglary and robbery as well as felony conspiracy charges.

Additional investigation revealed three other individuals to be involved. They were identified as Mr. David Watt Kelly of Concord, Mr. James Bryant Drye of Kannapolis, and Ms. Leah Margaret Miller of Kannapolis. Kelly was arrested on August 1st with Drye and Miller turning themselves in on August 2nd. All four individuals are currently in custody at the Stanly County Jail where they are charged with 1st degree burglary, robbery with a dangerous weapon, and felony conspiracy charges.
