

Welcome to all of our readers to the March 2015 edition of the Locust Police Department Community Newsletter. Spring is rapidly approaching, which is bringing a huge smile to my "sun hungry" wife's face. Warmer weather brings with it the opportunities for more outdoor activities, yard projects, and vacations to places both sunny and sandy. As a law enforcement officer however, you learn that warmer weather also brings with it elevated criminal activity, but we will continue to combat and prevent the best we possibly can. This month's newsletter will be very brief containing just a stat summary, some department news, and last month's statistics. There have been some changes at our department with a few more to come. Nothing negative has occurred, just some changes in the department that are noteworthy that I'll update you on in April's edition. I personally have had a hectic last couple of months which is part of the reason this edition will be super brief. So without further, let's get started with this month's newsletter...

#### LOCUST POLICE DEPARTMENTAL "STATS" FOR FEBRUARY 2015

Department "stats" for the month of February 2015 can be found directly following the newsletter. Last month was a very unique one for the department. January ended with a pursuit that resulted in an arrest but also a wrecked patrol car and another patrol car damaged. This resulted in a few of our officers playing "musical cars" for some of the month while others still remain in different vehicles for the time being. I spent the first two weeks of February in Salemburg at the NC Justice Academy participating in an 80 hour Crime Scene Investigation class. One of the weeks I was in Salemburg we had another officer attending RADAR operator school as well. The rest of the month we also had several officers catch the various bugs going around resulting in multiple lost shifts. During these times, we assure the city is adequately covered however it does often result in one less patrol officer for the shift affected. These absences for training and sickness likely explain why some of the statistics last month appear down from our typical average.

Total incident types/offenses for February were 125, down from the 148 the previous month, and completed incident reports were down eight to 118. Looking at the numbers, the great news is that despite being down some officers at different times of the month, there were no increases in "trouble" calls that warrant additional concern and everything still appeared around average.

One of the most glaring numbers that was affected due to officers absent was the 1,399 business and neighborhood checks for the month, quite a bit lower than our typical monthly average. This number still equates to an average of 50 area patrols daily.

There were 23 arrest charges for the month, a number that is slightly higher than average for typical months. Five of the charges were for misdemeanor larceny and four each were for failure to appear warrants and assault on a female.

Another number that speaks to the absence of patrol officers throughout the month were the 69 citation charges issued when our typical average is in the low 100's. 79 additional traffic stops resulted in warnings issued.

Finally, 11 traffic crashes were reported in February, with seven being reported on Locust streets and highways. Two of those seven however were due to those pesky deer that tend to venture out on the highway from time to time. Thankfully no injuries to the drivers were reported in those cases. Unfortunately their vehicles and the deer involved were not as lucky.

#### LOCUST POLICE DEPARTMENT NEWS

Several Locust officers recently completed training to further their education and knowledge while performing their duties, or to certify them for areas of specialization within the department.

I am unsure if I previously mentioned this accomplishment, but Officer Brittany Tucker completed a 40 hour Field Training Officer course in early December. This course known as an "FTO" certification class teaches officers how to effectively train new hires to ready them for the responsibilities of a patrol officer. Every new hire is usually paired with two separate FTO's over a four month period to learn how to perform their duties correctly, ethically, and efficiently. These FTO's have to sign off on the new hire before they are "cut loose" to be on their own. Officer Tucker joins Sergeant Rick Crayton, Sergeant Steven Smith, and Officer Kevin O'Connor as certified FTO's currently in the department's patrol division.

Officer Tucker along with Officers T.J. Smith and Brandon Stancil also re-certified as RADAR operators with the department over the last two months. This re-certification is mandatory with North Carolina every three years to assure officers can still efficiently approximate vehicle speeds, use RADAR units correctly, and know the laws and functions associated with RADAR proficiently. All three officers successfully re-certified to be RADAR operators for the next three years.

Another Locust officer joined the department's ranks of certified RADAR operator as Officer Trent Middlebrooks completed the initial RADAR operator course in early February. With Officer Middlebrooks' certification, every current Locust patrol officer is RADAR certified.

As I've previously stated, I completed an 80 hour Crime Scene Investigation class in February. This course covered all aspects of crime scene investigation including evidence recovery, photography, scene sketching etc. I also completed a 16 hour Advanced Interview and Interrogation course in mid-March, furthering my previous completion of the 40 hour Basic Interview and Interrogation course. Both courses were taught by Mr. Don Rabon, former law enforcement officer, Justice Academy assistant director, and accomplished author. Mr. Rabon has published five books on the art of interviewing suspects and witnesses in criminal activity. He is not only a very entertaining instructor but also supremely knowledgeable in the field.
