

Welcome all to the last day of the month edition of the May 2015 Locust Police Department Community Newsletter. I've finished my first full month as Detective for the department and what a whirlwind it has been. Ironically (and also blessed we are as a city *knock on wood*), the amount of actual major investigations have been small but all else entailed with my new duties have kept me on my toes as well as busy for most of every shift I work. In addition our department's long time secretary and record keeper went out for a much needed surgery last month which had us all having to step up to keep the day to day operations of the department running smoothly. Please if you would keep Mrs. Hartsell in your thoughts and prayers for a full, smooth, and speedy recovery.

If you the Locust residents we proudly serve haven't noticed a decrease in our service to you then we know we're still doing okay by you despite the added responsibilities. Everything being said, I have really taken to my new position with the department and feel incredibly blessed to be in it, as well as to work for the wonderful city and residents that I am so fortunate to work for.

Essentially a stats only edition of the newsletter this month and for that I apologize. As a consolation, I can assure that nothing has occurred that warrants any additional advisories or warnings. The unlocked vehicle break-ins have seemed to subside once again (again...*knock on wood*). I have a few theories about why but nothing conclusive. The perpetrator(s) could have been arrested for something else or somewhere else, but it could be due to the majority of our residents heeding the advisories and locking their doors or at least leaving valuables out of their cars. The majority of the vehicles that were broken into during the month and a half long "spurt" we experienced had very little of any value taken. I will also always believe that the extensive overnight patrols our officers at least attempt to do limit the amount of overall break-ins we experience in the city. "Theories" related to crime speak against my philosophies but you'll never fully convince me that it at least can't "hurt" anything to patrol extensively.

LOCUST POLICE DEPARTMENTAL "STATS" FOR APRIL 2015

Department "stats" for the month of April 2015 can be found directly following the newsletter. Total incident types/offenses for April were 160, and completed incident reports were 136. This equaled out to a relatively routine daily average of 4.5 incident reports recorded. Call types were of the normal variety however ten reports related to larcenies from vehicles is a trend that continued from the previous month but has since subsided for the most part. We also had ten fraud reports for the month but the majority was related to obtaining property by false pretense fraud at our Wal-Mart location (An example is when a perpetrator takes a stolen item and "returns" it to Wal-Mart for a refund. This type of criminal activity has long been our city's most prevalent source of "serious" crime since it is considered a felonious act).

Business and neighborhood checks were logged as 1582 for the month. 827 of these were neighborhood patrols and the total amount resulted in a daily average of 52.7 patrols conducted.

16 arrest charges were made last month with four being on failure to appear in court charges and four on misdemeanor larceny. An additional two arrest charges were for driving while impaired.

Citation charges were at 83 for April with 48 being for speeding offenses. 107 additional traffic stops resulted in warnings issued.

Finally, 10 traffic crashes were reported in April.

For the first third of 2015, the department has responded to 599 offense/call types and recorded 528 incident reports for a monthly average of 132 incident reports taken. 6,694 patrols have been conducted by the department for a monthly average of 1674. 90 arrest charges have been made by the department with 18 being for misdemeanor larceny and 17 on failure to appear charges. 316 citation charges have been issued by the department for a monthly average of 79. An additional 383 warnings have been issued by the department for a monthly average of 96. 44 traffic crashes have been reported this year which include crashes on our roadways as well in Locust parking lot areas.
