SUMMARY OF 2020 STATISTICS

OFFENSE TYPES/INCIDENT REPORTS

As it has become an annual event to report, law enforcement activities and statistics for the City of Locust in 2020 again showed the result of low criminal activity which continues to make Locust an extremely safe city to visit and live. 2020 statistics as well as a comparison to past years does also show that although crime is low, the tremendous growth that has occurred and is ongoing in Locust has resulted in a continuously elevated call volume for our agency which is expected to continue. Statistics documented by the Locust Police Department for the 2020 calendar year showed a 16.1% increase in documented offense types and a 10.7% increase in recorded incident reports. Some increase was seen in the majority of statistical categories which certainly demonstrated an increased call volume but did not indicate a significant increase in criminal activity of concern. Despite any statistical increases involving calls that were potentially criminal in nature, numbers continued to show an overall low daily incidence of larceny, fraud, and assault activity and near zero incidents of violent crime. The final numbers do indicate that in 2020 Locust remained and still remains a very safe city with an overall low volume of crime and criminal activity.

For 2020, the Locust Police Department continued with its policy of reports being documented for any dispatched calls where interaction with the public occurred, a policy the department plans to continue until call volume dictates a revision. There was a 10.7% increase in documented incident reports compared to 2019, and reported offenses documented within those reports increased by 16.1% from the previous year. Reported offenses would be the alleged criminal activity or other circumstances involved in each recorded incident report and can contain up to three per report. Generally speaking, non-criminal reports seldom have more than one reported "offense type" whereas criminal reports often contain more than one "offense type" involved in the incident (Example – An escort request is typically a stand-alone request ("offense type") however a breaking and entering offense also usually includes a larceny offense as well).

General service call types were up 5.7% from the previous year and these non-criminal call types continue to represent the largest percentage of dispatched calls received. General service includes escort

requests, medical and fire calls, and general calls for service. A 44% increase seen in calls for service following a 79% increase in 2019 shows a much more regular request for law enforcement response which could be indicative of an increased population.

General investigation call types were up 13.6% from 2019 which follows increases every year since 2015. Calls considered as general investigation are at times non-criminal in nature but do require investigation by the department to determine the actual circumstances. Of note in this category, investigation calls increased by 68.3%, and this is another call type that could be indicative of population growth. Disturbance call types, also potentially growth-based were up 18.3% which followed a 2.9% increase in 2019 and a 12.2% increase in 2018. Six missing person reports for the year were not determined to involve foul play and those "missing" were located or determined to not actually be missing.

Again in 2020, if accounted for the overall rate of incidence, statistics were positive in the category involving call types related to property and financial crime. There was again however an overall increase in property crime offenses for the year with 30 additional property and financial crime offenses reported from the number in 2019. Overall, this represented a 10.6% increase in call types related to theft or fraud. Breaking this down further, there was a 17.3% increase in business related larcenies although this was only an increase of 28 incidents over the course of the year from last, and fraud related incidents increased by 38.6% but only saw 17 additional incidents from 2019. Residential related larcenies decreased by 28% and vehicle related larcenies also decreased by 15.7%. Overall, personal larceny affecting persons, vehicles, or residences continued to be extremely low showing a daily average occurrence of just 0.20, or roughly one incidence every five days. This daily average occurrence was .01 lower than in 2019. It should also be noted in 2020, that the Locust Police Department showed a 69.9% clearance rate in property crime/fraud related reports meaning that essentially 70% of the time for the year, the Locust Police Department made an arrest or achieved another satisfactory disposition in property crime and fraud related incidents (See 2020 Annual Clearance Statistics Report).

General law enforcement/criminal activity offense types showed a significant category increase in 2020 and were up 47.9% from 2019. Increases were seen in every type of offense in this category with the most significant seen in traffic offenses that required an incident report. For traffic stops/offenses where general traffic citations or warnings are issued, Locust officers are not required to produce an incident report. If a traffic stop began with a traffic violation but resulted in an arrest, warrants being served, drugs being seized, or the vehicle towed, they require the officer to produce an incident report which would register in this category.

Alcohol and drug related offense types also shows a significant increase of 57.8% for the year from 102 in 2019 to 161 in 2020. Drug related offenses increased 60% from 75 to 120 for the year and can be attributed to more proactive drug enforcement efforts by Locust officers. Reported drug related offenses are any incidents where charges related to drugs result.

In the physical crime category, assault type offenses decreased 23.8% for the year which followed a 27.6% decrease the year prior. Reported assaults are another offense type where it can be realistically argued that an increase in population could result in more incidents of assault occurring however the city did not experience that association in 2020. This statistic for the year represents a daily average reported occurrence of assaults in Locust of just .04 which makes for an extremely low frequency of occurrence. This daily average occurrence is also .02 lower than in 2019.

Other offense types reported for 2020 were 4 sex offenses, 2 robbery or personal larceny from the person related offenses, and 8 designated death investigations along with one homicide. The four sex offenses reported were determined to be unfounded and the robbery related offenses resulted in arrest. The death investigations did not involve foul play with all eight confirmed to be a result of health issues/natural causes. The homicide marked only the third known reported homicide in Locust history and the first since 2015. An arrest of the homicide suspect was made within 24 hours by Locust investigators.

A six-year comparison of incidents and offense types was also produced showing the year to year category tallies from 2015-2020. In review of the comparison there is apparent growth in viewing the year to year numbers for documented offense types (+15.8% from 2015 to 2020) and completed incident reports (+14.2% from 2015 to 2020). Residential and commercial growth also is apparent in the increases on average seen for documented call/offense types however when viewing the numbers tallied there is no year to year increase that appears to be alarming, concerning, or drastic showing Locust to be a very safe city even as growth continues.

BUSINESS/NEIGHBORHOOD PATROLS

For 2020, there was a tremendous increase in completed patrols by Locust officers from 20,490 in 2019 to 25,660 this year. This represented a daily average of completed patrols of 70.3 in 2020. Regular and frequent patrols of businesses and neighborhoods in Locust remain a heavily emphasized policy for all Locust patrol officers. Over six years, Locust officers currently patrol businesses and neighborhoods at a percentage of 41.6% greater than in 2015.

ARREST CHARGES

Arrest charges made by the Locust Police Department in 2020 represented the first year since 2012 where it is believed that statistical processing was correct and accurate after a previously unknown duplication that was occurring in the reporting database in all years prior. In 2019, we began manually tracking arrest charges so the reported number should be accurate and in 2020 we were able to further fine-tune our statistical tracking. For 2020, the Locust Police Department reported 373 arrest charges which would be a significant 86.5% increase from the previous year. It is noted that some of the increase is related to proactive policing by our officers related to warrant services and drug interdiction through traffic enforcement. The majority of the increase is related to the manual tracking of officer arrest charges which includes warrants obtained and served by other agencies. The sizeable increase in arrest charges for the year does not indicate a significant increase in criminal activity when compared to the tally of offense types and incident reports completed for the year. Of the charges made, warrant services related to failure to appear and misdemeanor larcenies topped the list with 35 and 33 respectively. The felony arrest charges that had the greatest number were 20 larceny by defeating antitheft device, 13 for the possession of methamphetamine, and 12 for felony larceny. Of the 16 possession of schedule VI arrest charges, some of those were also felonious amounts charged. Per our 2020 clearance statistic report, the Locust Police Department showed a 79.1% clearance rate in criminal incidents which would be all incidents deemed criminal in nature that resulted in either an arrest or had to be closed due to exhausted leads. That statistic also showed that 321 Locust incidents were closed by arrest which would include warrants obtained by Locust officers following investigations (See 2020 Annual Clearance Statistics Report). Due to the previously well-documented processing issues, a six-year comparison was not included for arrest charges.

CITATION CHARGES

Citation charges for 2020 saw a decrease of charges issued from the previous year. Some of this decrease can certainly be attributed to a greater call volume that has steadily increased since 2015 (17.3% increase) which ties our patrol division up from engaging in traffic monitoring and enforcement. Staffing changes and a younger department that we are still catching up on getting officers trained to be certified as RADAR operators certainly has affected our speeding enforcement. Finally, our officer's sound use of discretion in issuing warnings as opposed to citations would also contribute to a lower number total for the year. In 2020, Locust officers issued 1,312 warnings which amounted to an average of 109.3 per month. For the year, 910 citation charges were issued by Locust officers which amounts to a monthly average of 75.8. In a six-year comparison, Locust officers are issuing citation charges at a rate 18.8% lower than in 2015 but are issuing warnings at a rate 12.9% higher. It should be noted that issues related to speed have reduced considerably since the speed limit change from 35-45 along Main Street occurred in 2015/2016.

TRAFFIC CRASHES

Traffic crashes reported in the city for 2020 were 196, down one crash from the previous year. This number represented a monthly average occurrence of just over 16 crashes a month, but that included both

crashes occurring on Locust streets and highways as well as minor parking lot "fender benders". Intersections at West Main Street and Meadowcreek Church Road, North Central Avenue at Meadowcreek Church Road/Bethel Church Road, Main Street and Central Avenue, West Main Street and Renee Ford Road, and West Main Street and Red Bridge Boulevard continue to be locations where annually more crashes occur. In the six-year comparison, although there is a 28.1% increase in reported crashes since 2015, it should be noted that crashes in 2020 were lower than the numbers reported in 2016-2019.

OVERALL LAW ENFORCEMENT ACTIVITY

Overall, numbers related to dispatched calls generated and/or attended by Locust officers in 2020 compared to 2019 is where the growth of the city and area continues to be evident. Overall law enforcement activity are statistics compiled by Stanly Communications and represent all calls for the year as well as case numbers generated by the Locust Police Department. These numbers would also include all self-initiated activities by Locust officers such as traffic stops, or other observations made by officers on patrol that results in a self-initiation. Total calls also include events occurring in other jurisdictions close-by that included or required Locust Police Department presence.

In total, 5,986 calls were either dispatched to, initiated by, or attended by the Locust Police Department in 2020, 2.6% more than in 2019. There was a decrease in overall report numbers generated by the department with a 9.9% decrease documented compared to the prior year however this can solely be attributed to the reduction in traffic citation charges issued which would require a report number to be generated.

In a six-year comparison, the growth of Locust is most evident as dispatched calls have increased every year but one since 2015. In 2015, 5,105 calls were dispatched to or initiated by Locust officers and in 2020, the number was 5,986 for a 17.3% increase.

OFFENSE TYPES ARE COUNTED TOGETHER REGARDLESS OF THESE DISTINCTIONS
