Parks – Locust hosted the Dixie Youth District Tournament. The tournament profited approximately \$14,000 for the City. It was a great event. Hopefully we will be able to host the State Tournament in July 2022. Fall sports registration is open.

PW –Thanks to the department and the flow is looking great. Only 2 days over 300,000 gallons/day.

ABC/EDC/Small Bus. – ABC Store doing great, they are up 25% over last year. There is a new restaurant coming to the Food Lion shopping plaza called Roll and Bowl. City Administrator Cesar Correa reviewed the Retail Strategies presentation. The looked at all the data and compared it to peer communities. The developed a list of retailers that would benefit from our location and provided contact information to those retailers for the City to reach out to them to see about recruiting.

PD – Letter of appreciation from Stanly County EMS was presented regarding aid over incident. Police Chief Jeff Shew has created an insights and helpful information booklet for citizens and businesses.

P&Z – Presentation was given by Andrew Grant, Engineer for Smith Douglas Homes of the proposed neighborhood development for the property at 6370 NC Hey 24/27 that the rezone request public hearing that was held earlier in the evening. They are proposing 114, 90ft lots. Limited view from HWY 24/27 with an 8ft berm with trees and landscaping and 100ft buffer from highway to back of home lot. Sidewalk on one side of street and on street parking on the opposite side, walking trails and a playground. The rezoning request of 6370 HWY 24/27 from HC to Conditional OPS was discussed,

recommendation came unfavorable from the P&Z Board. Another rezoning request was discussed regarding 6719 HWY 24/27 from OPS to HC, this recommendation came favorable from the P&Z Board.

I move that the request by Smith Douglas Homes to rezone the parcel located at 6370 NC Hwy 24/27 E from HC Highway Commercial to OPS Conditional be approved. The proposed zoning is inconsistent with the 2014 Land Use Plan. Should the rezoning to OPS Conditional be deemed appropriate, the 2014 Land Use Plan should be modified to Medium Density Residential to reflect the proposed zoning and use.
