SUMMARY OF 2021 STATISTICS

OFFENSE TYPES/INCIDENT REPORTS

As it has become an annual event to report, law enforcement activities and statistics for the City of Locust in 2021 again showed the result of low criminal activity which continues to make Locust an extremely safe city to visit and live. 2021 statistics as well as a comparison to past years does also show that although crime is low, the tremendous growth that has occurred and is ongoing in Locust has resulted in a continuously elevated call volume for our agency that was down from the number in 2020 but significantly greater than 5 years ago in 2017. Statistics documented by the Locust Police Department for the 2021 calendar year showed an 8.3% decrease in documented offense types and a 5.9% decrease in recorded incident reports. Some increase was seen in some statistical categories which certainly showed aspects of an increased call volume, but decreases were seen in many reported incidents related to criminal activity. Numbers continued to show an overall low daily incidence of larceny, fraud, and assault activity and near zero incidents of violent crime. The final numbers do indicate that in 2021 despite a rapidly growing city, Locust remains a very safe city with an overall low volume of crime and criminal activity.

For 2021, the Locust Police Department continued with its policy of reports being documented for any dispatched calls where interaction with the public occurred, a policy the department plans to continue until call volume dictates a revision. There was a 5.9% decrease in documented incident reports compared to 2020, and reported offenses documented within those reports decreased by 8.3% from the previous year. Reported offenses would be the alleged criminal activity or other circumstances involved in each recorded incident report and can contain up to three per report. Generally speaking, non-criminal reports seldom have more than one reported "offense type" whereas criminal reports often contain more than one "offense type" involved in the incident (Example – An escort request is typically a stand-alone request ("offense type") however a breaking and entering offense also usually includes a larceny offense as well).

General service call types were up 7.6% from the previous year and these non-criminal call types continue to represent the largest percentage of dispatched calls received. General service includes escort requests, medical and fire calls, and general calls for service. The 7.6% increase which follows a previous 44% and 79% increase the prior two years shows a much more regular request for law enforcement response which could be indicative of an increased population.

General investigation call types were down 15.6% from 2020 which had followed increases every year since 2015. Although the overall category number was down, it was still significantly higher than in 2016 and 2017 (5-6 years prior). Calls considered as general investigation are at times non-criminal in nature but do require investigation by the department to determine the actual circumstances. Of note in this category, seven missing person reports for the year were not determined to involve foul play and those "missing" were located or determined to not actually be missing.

General law enforcement/criminal activity offense types showed a very minute category increase in 2021 and were up .73% from 2020. Increases were seen in many offenses in this category with the most significant percentage increase seen in weapons violations though only increasing by 5 overall incidents for the year.

Again in 2021, if accounted for the overall rate of incidence, statistics were extremely positive in the category involving call types related to property and financial crime. There was an overall decrease in property crime offenses for the year for the first time in seven years and the overall reported number was the lowest recorded since 2017. Overall, there was a sizeable 25.3% decrease in call types related to theft or fraud. Breaking this down further, there was a 25.8% decrease in business related larcenies and fraud related incidents decreased by 16.4%. Residential related larcenies recorded the same number as 2020 (18) and vehicle related larcenies decreased by 46.5%. Overall, personal larceny affecting persons, vehicles, or residences continued to be extremely low showing a daily average occurrence of just 0.11, or roughly one incidence every ten days. This daily average occurrence was .09 lower than in 2020 when an incidence occurred roughly every 5 days. It should also be noted in 2021, that the Locust Police Department showed a 66.5% positive clearance rate in property crime/fraud related reports meaning that essentially 67 of every 100 property crime or fraud incidents, the Locust Police Department made an arrest or achieved another satisfactory disposition (See 2021 Annual Clearance Statistics Report).

Alcohol and drug related offense types also showed a significant decrease of 31.7% for the year from 161 in 2020 to 110 in 2021. Drug related offenses decreased 31.7% from 120 to 82 for the year. Reported drug related offenses are any incidents where charges related to drugs result.

In the physical crime category, assault type offenses increased 18.8% for the year but this represented only a small jump from 16 reported in 2020 to 19 in 2021. This statistic for the year represents a daily average reported occurrence of assaults in Locust of just .05 which makes for an extremely low frequency of occurrence. This daily average occurrence is also just .01 higher than in 2020.

Other offense types reported for 2021 were 6 sex or indecent liberty related offenses, with zero reported robbery or personal larceny from the person related offenses, and 2 designated death investigations. The death investigations did not involve foul play with both confirmed to be a result of health issues/natural causes.

A six-year comparison of incidents and offense types was also produced showing the year-to-year category tallies from 2016-2021. In review of the comparison there is apparent growth in viewing the year-to-year numbers for documented offense types and completed incident reports when directly comparing the annual period five and six years ago. Residential and commercial growth is apparent in these increases however when viewing the numbers tallied there is no year-to-year increase that appears to be alarming, concerning, or drastic showing Locust to be a very safe city even as growth continues.

BUSINESS/NEIGHBORHOOD PATROLS

For 2021, there was a tremendous increase in completed patrols by Locust officers from 25,660 in 2020 to 28,422 this year. This represented a daily average of completed patrols of 77.9 in 2021. Regular and frequent patrols of businesses and neighborhoods in Locust remain a heavily emphasized policy for all Locust patrol officers. Over six years, Locust officers currently patrol businesses and neighborhoods at a 54.3% greater percentage compared to 2016.

ARREST CHARGES

Arrest charges made by the Locust Police Department in 2021 were reported at 320 for the year which would be a 14.2% decrease from the previous year. On an extremely positive note, the only reasonable explanation in the department's view for the decrease is a reduced rate of criminal activity in Locust based on a similar reduction in reported offenses and recorded incident reports in contrast to a significant increase in traffic enforcement by Locust officers. Of the charges made, warrant services for various crimes and failure to appear warrants along with misdemeanor larceny charges topped the list with 39, 33, and 33 respectively. The felony arrest charges that had the greatest number were 18 for the possession of methamphetamine and 13 for larceny by defeating anti-theft device. It should also be noted that 16 resist, delay, and obstruct charges were made during the year which could be a troubling statistic mirroring an increased incidence of resistance to law enforcement authority nationwide. Per our 2021 clearance statistic report, the Locust Police Department showed a 76.7% clearance rate in criminal incidents which would be all incidents deemed criminal in nature that resulted in either an arrest or had to be closed due to exhausted leads. That statistic also showed that 360 Locust incidents were closed by arrest which would include warrants obtained by Locust officers following investigations (See 2021 Annual Clearance Statistics Report). Despite the decrease for the year compared to 2020, 320 charges for the year is still up significantly from 2019 when 200 were recorded. The ongoing deficiencies related to reporting philosophies by the county jail has made it somewhat more difficult to always report arrest charges accurately, but we believe that particularly the last two years the reported number is accurate.

CITATION CHARGES

Citation charges for 2021 saw a tremendous increase in overall traffic enforcement by Locust officers in both charges and warnings issued from the previous year. In 2021, Locust officers issued 1,517 warnings which amounted to an average of 126.4 per month. Also for the year, 1,279 citation charges were issued by Locust officers which amounts to a monthly average of 106.6 and represented a 40.6% increase from 2020. In a sixyear comparison, Locust officers are conducting traffic enforcement at a similar rate from 5-6 years prior but notably increased in comparison to 2018-2020. A decrease in other calls and criminal activity this year contributed to that as Locust officers had more opportunity to conduct traffic enforcement. Adequate staffing and better trained officers also contributed to more involvement with traffic enforcement.

TRAFFIC CRASHES

Traffic crashes reported in the city for 2021 were 202, up six reported crashes from the previous year for a 3.1% increase. This number represented a monthly average occurrence of close to 17 crashes a month, but that included both crashes occurring on Locust streets and highways as well as minor parking lot "fender benders". Intersections at Main Street and Central Avenue, West Main Street and Browns Hill Road, West Main Street and Red Bridge Boulevard, the entry/exit of Wal-Mart and West Main Street, and the parking lots of Wal-Mart and Food Lion continue to be locations where annually more crashes occur. In a six-year comparison, reported crashes since 2016 have stayed in a range within 20 crashes each year. In 2016, 220 crashes were reported with 202 being reported in 2021.

OVERALL LAW ENFORCEMENT ACTIVITY

Overall, numbers related to dispatched calls generated and/or attended by Locust officers in 2021 compared to five-six years prior is where the growth of the city and area is evident however 2021 was the lowest reported number since 2018. Overall law enforcement activity are statistics compiled by Stanly Communications and represent all calls for the year as well as case numbers generated by the Locust Police Department. These numbers would also include all self-initiated activities by Locust officers such as traffic stops, or other observations made by officers on patrol that results in a self-initiation. Total calls also include events occurring in other jurisdictions close-by that included or required Locust Police Department presence.

In total, 5,771 calls were either dispatched to, initiated by, or attended by the Locust Police Department or occurred in Locust areas in 2021, 3.6% less than in 2020. There was a significant increase

in overall report numbers generated by the department with a 21.1% increase documented compared to the prior year however this can solely be attributed to the increase in traffic citation charges issued which would require a report number to be generated.
In a five to six-year comparison, the growth of Locust is most evident as dispatched calls have increased. In 2017, 5,121 calls were dispatched to or initiated by Locust officers and in 2021, the number was 5,771 for a 12.7% increase.

OFFENSE TYPES ARE COUNTED TOGETHER REGARDLESS OF THESE DISTINCTIONS
