ANALYSIS

Eight percent increase in overall incident reports taken in addition to January 2022 resulting in multiple officers missing time due to illness and increased efforts to slightly reduce overall travel due to significantly elevated fuel costs resulted in percentage decreases in overall patrols and traffic enforcement. Criminal charge related reports and arrest charges were also down from the same period in 2021 which is a positive development.
